



Brown County Board Minutes

June 1, 2021

The Brown County Commissioners met in regular session on Tuesday, June 1, 2021, at 5:15 P.M., in the Brown County Courthouse meeting room with members Chairman Buddy Small, Dennis Bauer and Reagan Wiebelhaus present. Also present was Brown County Clerk Travis Hobbs (BCC).

Chairman Small acknowledged the Open Meeting Act posted near the entrance to the Meeting Room.

Those in attendance rose and stated the Pledge of Allegiance.

Chandra Giles spoke to the Board regarding purchasing a new car for the extension agency. The agency has priced a 2022 Jeep Grand Cherokee and will need an additional \$3000.00 total from the three counties. Brown County will pay the entire amount up front and Rock and Keya Paha will reimburse in their next budget.

Wiebelhaus moved to use \$3,000.00 from Miscellaneous General towards the purchase of a 2022 Jeep Grand Cherokee. Small seconded. Roll Call: All three Ayes, motion carried.

Bauer moved to reappoint Raymond Buddy Small to represent Brown County Board as the member to Sandhills Care Center Board of Directors. Wiebelhaus seconded. Roll Call: All three Ayes, motion carried.

Small moved to approve Resolution #2021-27 transferring \$6,000.00 from Miscellaneous General within the General Fund to the Veteran Service Budget in the General Fund. Wiebelhaus seconded. Roll Call: All three Ayes, motion carried.

Small moved to approve Resolution #2021-28 transferring \$10,000.00 from Miscellaneous General within the General Fund to the Jail Budget in the General Fund. Wiebelhaus seconded. Roll Call: All three Ayes, motion carried.

Small moved to approve payment of the claims. Bauer seconded. Roll Call: All three Ayes, motion carried.

Small moved to approve the minutes from the May 18, 2021 Commissioner meeting as written and officially recorded in Commissioner Book #22. Bauer seconded. Roll Call: All three Ayes. Motion carried.

Brown County Highway Superintendent Kenneth Turpin was not present but left an update of the road department projects which Chairman Small read.

No Public comments made.

Wiebelhaus moved to enter executive session for the purpose of discussing sensitive information regarding the sale of real estate in Brown County. Bauer seconded. Roll Call: All three Ayes, motion carried. Chairman Small restated the reason for executive session. The Board entered executive session at 5:40 pm. Wiebelhaus moved to come out of executive session at 6:45 pm. Bauer seconded. Roll Call: All three Ayes, motion carried.
