September 21, 2021

The Brown County Commissioners met in regular session on Tuesday, September 21, 2021, at 5:15 P.M., in the Brown County Courthouse meeting room with members Chairman Buddy Small and Reagan Wiebelhaus present. Dennis Bauer was absent with an excused absence. Also present was Brown County Clerk (BCC) Travee Hobbs.

Chairman Small acknowledged the Open Meeting Act posted near the entrance to the Meeting Room.

Those in attendance rose and stated the Pledge of Allegiance.

The Board discussed a subdivision approval.

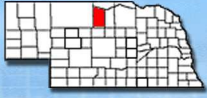

Small moved to approve Resolution#2021-47 a budgeted transfer of \$250,000.00 from the Miscellaneous General Fund within the General Fund to the County Highway Fund. Wiebelhaus seconded. Roll Call: Wiebelhaus Aye, Small Aye and Bauer Absent, motion carried.

Small moved to approve the claims and the Brown County Sheriff's monthly fee report for July of \$327.47 and August of \$461.60. Wiebelhaus seconded. Roll Call: Wiebelhaus Aye, Small Aye and Bauer Absent, motion carried.
