January 3, 2023

The Brown County Commissioners met in regular session on Tuesday, January 3, 2023, at 5:15 P.M., in the Brown County Courthouse meeting room with members Chairman Buddy Small and Dennis Bauer present. Member Wiebelhaus was absent with an excused absence. Also present was Brown County Clerk (BCC) Travis Hobbs.

Chairman Small acknowledged the Open Meeting Act posted near the entrance to the Meeting Room.

Those in attendance rose and stated the Pledge of Allegiance.

Bauer moved to approve minutes from the December 20, 2022, Commissioner meeting as written and officially recorded in Commissioner Book 23. Small seconded. Roll Call: Bauer Aye, Small Aye and Wiebelhaus Absent, motion carried.

Brown County Highway Superintendent (BCHS), Kenneth Turpin, due to the winter storm, was not present and did not leave a report. Small stated that the Road crew has been working hard at getting roads opened and widened the last couple of weeks.

Bauer read Resolution #2023 – 1 Road Study Report for Road #38 as prepared by BCHS Turpin, the report is required for the proposed road closure. BCHS Turpin requested that a hearing be set in the future. The Board set the hearing for Tuesday, February 7, 2023, at 5:30 p.m.

Brown County Weed Superintendent Scott Erthum was unable to be present due to the weather conditions. That item is tabled to the next meeting.

The Board viewed the Brown/Rock Interlocal Emergency Manager Deputy Agreement.

Bauer moved to approve Resolution #2023 – 2 Brown/Rock Interlocal Emergency Manager Deputy Agreement and authorize Chairman Small to sign. Small seconded. Roll Call: Small Aye, Bauer Aye and Wiebelhaus Absent, motion carried.

Bauer moved to approve Resolution 2023 – 3 transferring \$250,000.00 from Miscellaneous General within the General Fund to the County Highway Fund. Small seconded. Roll Call: Bauer Aye, Small Aye and Wiebelhaus Absent, motion carried.

Small moved to approve payment of the claims. Bauer seconded. Roll Call: Small Aye, Bauer Aye and Wiebelhaus Absent, motion carried.

No Public comments were made.

The meeting was adjourned at 5:30 P.M.
